Dear Parent

Your child has been selected to attend the Avion Aerial & Circus School in Smeaton Grange on Monday, 18 November 2019. This is a reward excursion to introduce the Circus Club students to new and exciting circus skills that we are unable to do during Circus Club on Friday lunchtimes.

The Circus Club will leave Ambarvale High School by **minibus and private car driven by Miss Reilly and Miss Nunes** at recess and will arrive at Avion Aerial & Circus School at approximately 11:20am.

They will be completing a two hour class, broken into two 1 hour sessions with a short 15 minute break in between. Session 1 will include ground skills, such as juggling, hula hooping and hand balancing. Session 2 will include aerial skills, such as aerial silks and lyra. Students will be returning to school at approximately 2:15pm. Students will need to bring their own lunch and bottle of water on the day.

When: Monday, 18 November 2019. Students will attend normal classes period 1 & 2, and leave school at recess.

Cost: Nil. Cost will be covered by Ambarvale High School.

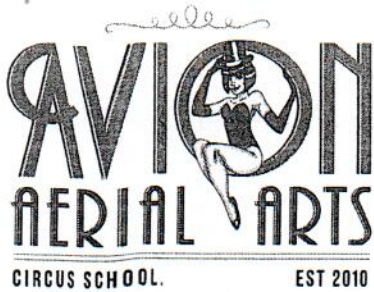

Liability Release

Release of Liability Agreement

I FULLY UNDERSTAND that:

- a) **AERIAL ACROBATICS INVOLVES RISKS AND DANGERS** of serious bodily injury, including permanent disability, paralysis and death ("Risks"). My participation is purely voluntary and I elect to participate in spite of the risks.
- b) These Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the Releases named below;
- c) I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
- d) **I FULLY ACCEPT AND ASSUME ALL SUCH RISK AND ALL RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES** I incur as a result of my participation in the activity.
- e) I acknowledge that **AERIAL ACROBATICS AND CIRCUS ARTS** entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. I understand that such activities always involve certain risks, including but not limited to, death, serious neck and spinal injuries resulting in complete or partial paralysis, brain damage, and serious injury to virtually all bones, joints, muscles, and internal organs, and the mats and other safety equipment and apparatus provided for my protection including the active participation of a teacher who will spot or assist in the performance of certain skills, may be inadequate to prevent serious injury. The risk of harm may be limited by all of the safety equipment and trained coaches, but never eliminated. I understand that participation in Circus Arts and Aerial Acrobatic conditioning, stretching and other activities may leave me vulnerable to the reckless actions of their participants who may not have complete control over their actions or who may not see other students in the area. I am voluntarily participating in this activity with knowledge of the risks involved and hereby agree to accept any and all inherent risks of property damage, personal injury, or death.

- f) I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect. By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in activities at Avion Aerial Arts, or with Melissa O'Toole or her agents, owners, officers, volunteers, participants, employees, workshop teachers, independently contracted instructors, and all other persons or entities acting in any capacity on their behalf, I may be found by a court of law to have waived my right to maintain a lawsuit against Avion Aerial Arts and/or Melissa O'Toole, and/or her agents, owners, officers, volunteers, participants, employees, workshop teachers, independently contracted instructors, and all other persons or entities acting in any capacity on their behalf on the basis of any claim from which I have released them herein.

- g) In consideration of the minor student (listed by name on the registration and entrance form) being permitted by Avion Aerial Arts to participate in its activities and to use its equipment and facilities, I further agree to indemnify and hold harmless Avion Aerial Arts, or with Melissa O'Toole or her agents, owners, officers, volunteers, participants, employees, workshop teachers, independently contracted instructors, and all other persons or entities acting in any capacity on their behalf from any and all claims which are brought by, or on behalf of Minor, and which are in any way connected with such use or participation by Minor. By agreeing to these terms, I am confirming that I am the parent/guardian of this student and have the legal ability to waive the above mentioned rights for the minor.

- h) In any event of an accident or emergency I hereby authorize myself or my child to be transported to a hospital for medical treatment and I hold Avion School of Aerial Arts and its representatives harmless in the execution of such. Additionally, I hereby agree to individually provide for all medical expenses which may be incurred by me or my child(ren) as a result of any injury sustained while participating at or for Avion School of Aerial Arts.
