TRREC Reward Excursion - Jamberoo Action Park Alternate Swim Challenge Test Information and Consent

Dear Parent

As your child was unable to attend the mandatory Swim Challenge Test scheduled for Monday, 2 December 2019, an alternate afternoon has been proposed by the school for your child to meet the Department of Education requirements for Jamberoo Action Park as an unstructured water activity.

Your child must attend and complete the 'challenge test' if they wish to attend the Jamberoo excursion on Friday, 13 December 2019.

Due to the nature of this amendment, there will be one teacher attending who will actively be supervising the 'challenge test' for students. As a result, a parent or a carer over the age of 18 years old **must be present** for the duration of the time at the venue. They will need to actively supervise their child during the entire stay at the venue. Parents will also be responsible for entry costing.

When: Tuesday, 10 December 2019.

Where: Gordon Fetterplace Aquatic Centre, The Parkway, Bradbury.

Transport: Students are to make their own way to and from the venue, accompanied by a parent.

Cost: Adult admission: \$6.50; Child admission \$4.20; Family (2 Adult & 2 Children or 1 Adult & 3 children) \$18.00. To be paid by parent/carers at the entrance gate to the pool. **No payments are to be made to the school.**

Time: 3:00pm – 3:30pm

What to bring: Swimmers, towel, sunscreen. Goggles are optional.
