## Educational Excursion Information and Consent Year 9 Commerce 'Consumer Choice' Excursion – Macarthur Square

Dear Parent

Year 9 Commerce have been studying as our first topic "Consumer Choice". In this topic, we have been learning about the buying decisions that consumers make and gaining an understanding of our legal rights and responsibilities as consumers.

As part of their learning outcomes, students will be attending an excursion to **Macarthur Square** where they will conduct a practical **Field Work Assessment Task**. This task will entail a formal investigation into key areas of the topic using methods such as observation, information gathering and data analysis. It should be noted that Students who are unable to attend the excursion would still need to complete the assessment in their own time.

**When:** Thursday, 28 March 2019

**Where:** Macarthur Square

**Itinerary and transport:** Students will be required to make their own way to Macarthur Square by 8:30am and will be dismissed from Macarthur Square at 2:45pm. **Students may require an OPAL card if they are catching a bus to and from the venue.**

Parents are responsible for their child's transport and safety prior to arrival at 8:30am at Macarthur Square and following 2:45pm when they are dismissed.

**(Please note: one of the activities in their Field Study will be a budgeting activity. This *can* be a simulation, but carers are asked to provide their child with a small amount for budgeted spending (no more than \$20) if their financial circumstances permit. It should be noted that this is not a compulsory cost of the excursion).**
